Simon: The Milton of the East, translations of Simon's works cover a range, from purpose-driven topic studies to interpretive Bible commentaries, poems, and hymns. Scholarship has so far placed Simon's poetical work on par with the bhakti classics of Ezhuthachen, the Father of modern Malayalam, and of Poonthanam, a Hindu metaphysical poet, both household names in India. But in this study, Varghese Mathai shows how Simon distinguishes himself by his contributions to numerous knowledge fields that bridge him to world literature, modern history, colonial studies, religion, apologetics, rhetorical studies, and more.
